

# Regina v Philip Arundel van der Westhuizen

## Appeal Decision of Magistrates' Court in the Supreme Court Gibraltar

4<sup>th</sup> Written Statement:

Apostle Paul, whom governments like to mis-quote [JAHTruth.net/noti](http://JAHTruth.net/noti) to justify their existence, said to obey **lawful** authority, not fraudulent legal authority, but not as clearly as Jesus and His other Apostles said it, because Paul did not spend long periods of time with, and learning directly from, Jesus, like the other Apostles did.

King of kings' Bible [JAHTruth.net/kofk-free/Bible](http://JAHTruth.net/kofk-free/Bible) Romans 13:1 Let every soul be subject unto the higher powers. For there is no power except of God: the powers that be are ordained by God.

13:2 Whosoever therefore resisteth the power, resisteth the ordinance of God: and they that resist shall receive to themselves damnation.

13:3 For (**lawful** – God's Law not legislation) rulers are not a terror to good works, but to the evil. Wilt thou then not be afraid of the power? Do that which is good, and thou shalt have praise of the same:

13:4 For he is the minister of God to thee for good. But if thou do that which is evil, be afraid; for he beareth not the sword in vain: for he is the minister of God, a revenger to [execute] wrath upon him that doeth evil.

13:5 Wherefore [ye] must needs be subject, not only for wrath, but also for conscience sake.

Titus 3:1 Put them in mind to be subject to (**lawful** – God's Law not legislation) principalities and powers, to obey magistrates, to be ready to every good work,

Peter said: 1 Peter 4:16 Yet if [any man suffer] as a Christian, let him not be ashamed; but let him glorify God on this behalf.

4:17 For the time [is come] that Judgment must begin at the House of God: and if [it] first [begin] at us, what shall the end [be] of them that obey not the gospel of God?

4:18 And if the righteous scarcely be saved, where shall the unGodly and the sinner appear?

Peter and **ALL** the Apostles said: Acts 5:29 Then Peter and the [other] Apostles answered and said, **We ought to obey God rather than men.**

If we obey God, we obey His Law, not fraudulent legislation that God prohibits:

Deuteronomy (5<sup>th</sup> Book of The Laws of God) 4:2 **Ye shall not ADD unto the word** which I command you, **neither shall ye diminish [ought] from it**, that ye may keep the **Commandments** of the "I AM" your God which I **COMMAND** you.

12:8 Ye shall **not** do after all [the things] that we do here this day, every man whatsoever [is] right in **his own eyes**.

12:32 What thing soever I command you, observe to do it: **thou shalt not add thereto, nor diminish from it.**

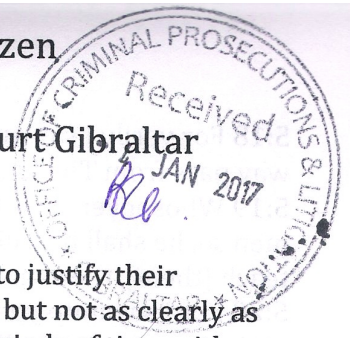
Matthew (Jesus)5:17 Think not that I am come to destroy The Law, or the Prophets: I am not come to destroy, but to fulfill.

5:18 For verily I say unto you, Till heaven and earth pass, one jot or one tittle shall in no way pass from The Law, till all be fulfilled.


5:19 Whosoever therefore shall break one of these least COMMANDments, and shall teach men so, he shall be called the least in the Kingdom of heaven: but whosoever shall do and teach [them], the same shall be called great in the Kingdom of heaven.

5:20 For I say unto you, That except your righteousness shall EXCEED [the righteousness] of the lawyers and politicians, ye shall in no case enter into the Kingdom of heaven.
