

Regina v Philip Arundel van der Westhuizen

2nd Written Statement of Philip Arundel van der Westhuizen.

I hereby demand that the fraudulent charge against me, for being in Gibraltar without a valid permit, be discontinued:

1. I have shown my full Austrian EU passport (received on the 19th April 2016), at the last hearing on the 20 April 2016, which entitles me to live and work anywhere in Europe. And I had that entitlement since 1989, and have always been self-supporting.
2. I have also proved, with British Empire documents, that my body is British born, with its British parent and grandparent, and it being born in the "Union of South Africa" in 1960, which the 1953 Coronation Oath confirms was part of the British Empire (See Signed Coronation Oath at Jforjustice.net "Challenge").
3. But there is **no** Law in The Laws; the first five Books of The Old Testament / Pentateuch / Torah (means Law), that requires **any** of these papers anyway.
4. And human beings have **absolutely NO authority** to make any other laws than those God ordained, because The Law of God, that Mrs. Elizabeth Battenberg (misnomer QE2) swore to maintain to the **UTMOST** of her power, specifically **forbids** them and her from doing so:

King of kings' Bible JAHTruth.net/kofkad Deuteronomy (5th Book of The Laws of God) 4:2 **Ye shall not ADD unto the word** which I command you, **neither shall ye diminish [ought] from it**, that ye may keep the **Commandments** of the "I AM" your God which I **COMMAND** you.

12:32 What thing soever I command you, observe to do it: **thou shalt not add thereto, nor diminish from it.**

Matthew 5:17 Think not that I am come to destroy The Law, or the Prophets: I am not come to destroy, but to fulfill.

5:18 For verily I say unto you, Till heaven and earth pass, one jot or one tittle shall in no way pass from The Law, till all be fulfilled.

5:19 Whosoever therefore shall break one of these least **COMMANDments**, and shall teach men so, he shall be called the least in the Kingdom of heaven: but whosoever shall do and teach [them], the same shall be called great in the Kingdom of heaven.

5:20 For I say unto you, That except your righteousness shall **EXCEED** [the righteousness] of the lawyers and politicians, ye shall in no case enter into the Kingdom of heaven.

5. So the legislation that is relied on to detain me is null and void *ab initio* (from the start), and therefore without power / *ultra vires*; it directly contravenes Deuteronomy 4:2 and 12:32.
6. The legal system also has **no jurisdiction** over me, because its head; Mrs. Elizabeth Battenberg and therefore all her servants **lack authority**, them all having broken the Coronation Oath Pledge to:

“... maintain to the **utmost** of her power The Laws of God.”, and “The things which I have here before **promised I will perform and keep.**”, signed “Elizabeth R” (See Signed Coronation Oath at jforjustice.net “Challenge”).

There are also multiple other crimes, as explained in the first written statement of the 21 December 2015 - Contents sourced from jforjustice.net “Challenge”, which also renders the pretended authority null and void.

7. Furthermore the charge docket records my and the charging officer’s names in CAPITALS, which refers to secret government owned CORPORATIONS in our names, which are not us, and that certainly neither me nor my body’s parents ever gave consent to, or even knew about:

8. Those corporations contravene Deuteronomy 4:2 and 12:32 and are **condemned** by God, and the charge docket is also fraud thereby, but also because it quotes and relies on fraudulent legislation.
9. And to repeat, the legal system also “**Cannot Judge In Its Own Cause**”; I have been challenging its jurisdiction (jforjustice.net “Challenge”) from the beginning; hence the several requests (ignored) for an independent jury.
