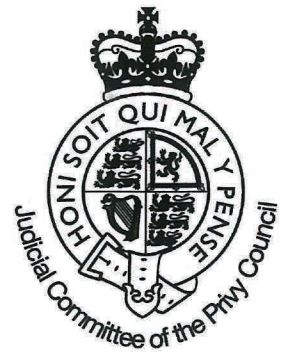

- Issues in the appeal

1. I was wrongfully arrested on 19th December 2015, and convicted by the Gibraltar Stipendiary Magistrates for, "being a non-Gibraltarian in Gibraltar without a valid permit or certificate" in terms of fraudulent legislation, on the 23rd August 2016.

2. I proved that he had no jurisdiction over me: his head; of the BAR, Mrs. Elizabeth M. A. Battenberg (alias Windsor), having been unlawfully crowned upon a fake 336lbs coronation stone copy of the 458lbs original, and is therefore not the lawful sovereign.

She also broke her televised 2 June 1953 sworn and signed Coronation Oath, with her multitudinous "royal assents" of legislation, contrary to Deuteronomy 4:2, 12:8 & 12:32 in "The Laws of God", which specifically forbid all legislation, and some of which legislation directly reverses Those Laws, which she "promised", over the Sovereign's Authorised 1611 King James Bible, and then kissed it, "to maintain to the utmost of her power ... So help her God." (See copy attached).

King of kings' Bible JAHTruth.net/kofk-free/Bible Deuteronomy (5th Book of The Laws of God) 4:2 Ye shall not ADD unto the word which I command you, neither shall ye diminish [ought] from it, that ye may keep the Commandments of the "I AM" your God which I COMMAND you.

12:8 Ye shall not do after all [the things] that we do here this day, every man whatsoever [is] right in his own eyes.

12:32 What thing soever I command you, observe to do it: thou shalt not add thereto, nor diminish from it.

She therefore never had any power or authority to delegate; from the very beginning, and the legislation is fraud, and she significantly compounded her crimes in 1988, again with malice aforethought, by ignoring Christ's Sheffield-High-Court-writ demand for His Throne.

I requested her, the Coronation Bible, and the signed Oath's presence at the hearing, to answer to those facts, which was ignored.

3. I also proved in several ways that I am British anyway, which the fraudulent legislation denies, which aptly demonstrates why The Laws of God forbid it, with,

(i) My, herein demonstrated, adherence to the meaning of the word British, which is Hebrew, from the two Hebrew words Berit and Ish, meaning Covenant-Men/ People JAHTruth.net/britca; that Covenant sworn with Moses at Mt. Sinai to keep and DO, FOREVER.

King of kings' Bible JAHTruth.net/kofk-free/Bible Deuteronomy (5th Book of The Laws of God) 29:14 Neither with you only do I make this Covenant and this Oath; 29:15 But with [him] that standeth here with us this day before the "I AM" our God, and also with [him] that [is] not here with us this day [thy children, in PERPETUITY]:

(ii) My body's 1960 British Empire birth; its birth certificate being headed "Union of South Africa" which matches exactly the 1953 Coronation Oath, "I will govern the Peoples of the Union of South Africa"; South Africa having sadly become a Republic only in 1962.

(iii) My body's English born grandparent Frank Rivers Arundel (which the UK Border Agency confirmed in writing) who married one of his cousins Winifred Marguerite Arundel in South Africa; and my body's late mother and brother being British and having had and still have British passports.

(iv) Also, having being raised Anglican and English speaking; in dual language British-Israel South Africa; the Dutch also being British Israelites - The Tribe of Zebulun, and The British Israel Tribe of Naphtali also having settled there JAHTruth.net/abraham; attended English-tradition St. Alban's College in Pretoria; was a member of the UK Chartered Institute of Management Accountants ... and more.

3. He ignored the irrefutable written and verbal arguments and evidence, and the several substantiating follow-on written arguments, and imposed a £200 fine with a deportation order.

4. After I produced, first, an emergency, and then a full, Austrian passport, which citizenship I acquired by marriage in 1989, he dropped the deportation order.

5. I appealed to the Gibraltar Supreme Court, and Chief Justice Anthony Dudley also ignored the same, and again further substantiating written arguments, presented in one of the most important documents ever lodged there; the 'Appellant's Response to Respondent's Skeleton Arguments' dated 11th/12th January 2017, him stating that they were a "belief" system, which is not factual counter-argument; to the very factual Coronation Oath for example, and saying that he was going to do what he was paid to do - showing bias, and he upheld the fine at that 13th January 2017 hearing.

6. I appealed to the Gibraltar Appeal Court, which also ignored the irrefutable arguments, them stating that they were "misconceived" and "spurious"; again providing no factual counter-arguments as to how they were so, because they could not, and also upheld the fine at that 30th March 2017 hearing.

6. Grounds of appeal

1. The extremely important law arguments that were presented to date, with their substantial backing - because they encapsulate many Truths THAT THIS PLANET HAS BEEN WAITING 2,000 YEARS TO HEAR JAHTruth.net, have life threatening consequences, but alternatively beautiful blessings JAHTruth.net/blescur, for the British people, and the WHOLE world, but the false judgements to date have so far proved the Prophecy that the WARNINGS would be ignored by most; being too otherwise occupied to devote time to them.

King of kings' Bible JAHTruth.net/kofk-free/Bible John (Jesus) 16:12 I have yet many things to say unto you, but ye cannot bear them now.

Matthew (Jesus) 24:37 But as the days of Noah [were], so shall also the coming of the Son of Man be.

24:38 For as in the days that were before The Flood they were eating and drinking, marrying and giving in marriage, until the day that Noah entered into the ark,

24:39 And knew not until The Flood came, and took them all away; so shall also the coming of the Son of Man be.

As with Noah, only a fragment should survive JAHTruth.net/noah, but the courts have the power to initiate the widespread acknowledgement of these enlightening Truths with righteous Judgement, or alternatively to stifle them as they have been up to now, which would alternatively exonerate or accuse them; now, and on the Last Judgement Day.

King of kings' Bible Ezekiel 33:6 But if the watchman see the sword come, and blow not the trumpet, and the people be not warned; if the sword come, and take [any] person from among them, he is taken away in his iniquity; but his blood will I require at the watchman's hand.

2. And while the lower courts have acted under significant biases via their pretended judges' BAR oaths of allegiance to the accused Mrs. Elizabeth Battenberg; the queen who never was JAHTruth.net/britmon, Messers. Maurice Kay, John Goldring and Martin Moore-Bick of the Appeal Court hearing, have, in addition, sworn privy counselor oaths, which evidences more and substantial bias in her favour, and therefore also at the Truth's, and my, expense:

Privy Counselors Oath: "You do swear by Almighty God to be a true and faithful Servant unto the Queen's Majesty, as one of Her Majesty's Privy Council. 3. But, those oaths can successfully be ignored, because she has demonstrated repeatedly, with her God-given free-will, that she is the greatest traitor to Him and Christ, on this Earth, and therefore the greatest criminal, having allowed her continued fake-crowning deception; by her repeated breaking of His Laws, and having concealed the Second Coming of Christ; the rightful British King JAHTruth.net/emmau2, and, to add insult to injury, having used her stolen position to enslave the British people. 5. And "justice must not only be done, but be seen to be done"; so therefore, for that to be so, as judges all swear to serve her and thus cannot be impartial, and it is a maxim in law that no man can judge in his own cause, or a cause to which he is a party, it **must** be done before an impartial jury, where she, and Mr. Ian Hamilton QC, who led the four Scottish Nationalists who removed the original 458lbs Palestine Porphyry Coronation Stone; Jacob's Pillar (of **UNION** of **JACK**ob flag fame JAHTruth.net/christfg); The Stone of Destiny; Lia Fail JAHTruth.net/liafail, on the 25th December 1950 back to Scotland, and substituted the fake copy on the 11th April 1951, can be called to confirm those facts.

6. So that, amongst other (from the most important 'Appellant's Response to Respondent's Skeleton Arguments' dated 11th/12 January 2017): "3.8 Our Wonderful King, The Prince of Peace will reinstate The Law and declare the Jubilee; the land will be redistributed along with all the wealth; our debts will be forgiven; including our mortgages, credit cards, rent-arrears, and all other forms of debt **slavery** and usury will be abolished, as He will be implementing God's Law and not Satan's man-made legislation."

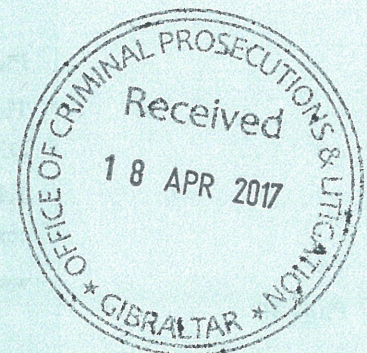
