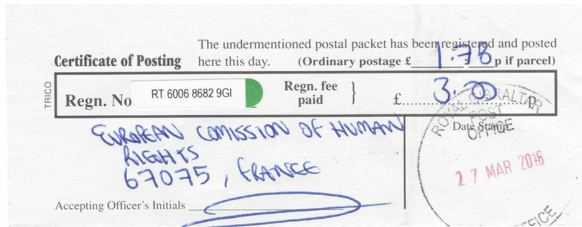

Subject matter of the application

E. Statement of the facts

- 56.
1. 08/06/2012 - I entered Europe with a Shengen visa in my South African passport (Doc. 2 Pages 12 & 13) to continue the "spiritual" work (points nos. 7 & 50) that I started there on 26/08/2010.
 2. 03/11/2012 - I came to Gibraltar where I continue that work.
 3. 19/11/2015 - The Royal Gibraltar Police arrested me because someone complained about the pamphlets - Truth - that I was distributing door to door (Doc. 40 P351).
 4. 19/11/2015 - The Royal Gibraltar Police then charged me with "being a non-Gibraltarian in Gibraltar without a valid permit or certificate" (Docs. 1 P1 & 2 P4). I responded "no jurisdiction" to all questions and statements telling them that I could prove it.
 5. 19/11/2015 - The Royal Gibraltar Police also charged me with "printing abusive matter" but that charge was kept in abeyance (Doc. 8 P110).

6. 21/12/2015 - I lodged a written challenge to Mrs. Elizabeth Battenberg's (alias queen) jurisdiction with the Gibraltar Magistrates' Court (Doc. 3 N.B. N.B. P24-52), with proof (i) that she is not the lawful sovereign and that she has committed multiple frauds: that she is the criminal who has no authority or jurisdiction over me, and I requested her presence at the hearing plus her signed 02/06/1953 coronation Oath and the Sovereign's Bible upon which she swore that Oath, to explain why she allowed her crowning upon a fake Coronation Stone/Throne and why she massively broke her Coronation Oath, and (ii) that the legislation that was used against me is not law but fraudulent legislation that "The Laws of God" forbid: Deuteronomy 4:2 12:8 12:32 (King of kings' Bible JAHTruth.net/kofk-free/Bible), which she "promised" and swore "to maintain to the UTMOST of her power", and has never done.
 7. 19/01/2016 - I lodged an Affidavit about my "spiritual" work and Gibraltar's special Prophesied destiny with Gibraltar Civil Status and Registrations (Doc. 4 P64) with a request for a Gibraltar British passport to continue that work unhindered (Docs. 5 P97 & 6 P99). And because I am British anyway by the Biblical/correct* definition; in addition to my body's granddad being born in England and he married his cousin, and my body's late mom and brother had and have British passports, plus other proofs. *UNION of the 12 Tribes (including South Africa) of JACKob flag is Christ's flag (Doc. 7 P103).
 8. 28/01/2016 - The Royal Gibraltar Police activated the "printing abusive matter" charge (Doc. 8 P110). I responded "no jurisdiction" to all questions and statements.
 9. 02/02/2016 - The Gibraltar Magistrates' Court first hearing: When asked if I was guilty or not I responded "no jurisdiction". I asked for a jury, and reminded them that "no man can judge in his own cause" and that I had two causes against them: (i) the challenge to their jurisdiction, and (ii) the brochures accusing them (Doc. 40 P351). They refused a jury, said they had jurisdiction, and would apply their "law", which I said was "legislation", not Law (see 6). (iii) I said I could prove that I was British, which they said I could do at the final hearing.
 10. 02/02/2016 - Gibraltar Civil Status and Registrations, on advice from the UK, refused me a British passport and referred me to a fraudulent legislation route, which does not cater for my spiritual-calling work (Doc. 9 P122). See my response to them at point 19.
 11. 08/02/2016 - The Gibraltar Magistrates' Court discontinued the charge "distributing abusive matter" (Doc. 10 P123).
 12. 03/03/2016 - Gibraltar Magistrates' Court hearing (Doc. 11 P124): I had just learned that I qualified for an Austrian passport due to my Austrian citizenship, which I acquired by marriage in the 1980s, which I explained at the hearing. I was denied an independent jury and Mrs. Battenberg's presence with requested exhibits. I proved that my body was born in the British Empire/ Commonwealth with its 1960 "Union of South Africa" birth certificate, which exactly matches the Coronation Oath's "govern the Peoples of" ... "the Union of South Africa". (South Africa sadly became a republic in 1961.). When asked if I accepted the evidence against me I said, "I don't accept anything: it all contravenes Deuteronomy 4:2 no jurisdiction" (Doc. 11 P136, 141, 159, 160, 161, 166, 167). The head of Civil Status and Registrations said that a person with an Austrian passport could stay longer than the initial tourist 3 months if they were a "job seeker, student, worker, self-sufficient ..." (Doc. 11 P144). My Affidavit (Doc. 4 P64) and my request for a Gibraltar British passport (Docs. 5 P97 & 6 P99) and residence application (Doc. 20 P190) all state my spiritual work under God's jurisdiction and my self sufficiency (See point 50). Regarding giving evidence I was told that, "Judge: The most advantageous to you is to take the oath ... you can be cross-examined on it ... etc." (Doc. 11 P157). But Mrs. Battenberg, who swore the most important Oath and then broke it, was not presented for cross-examining, which is blatantly unfair? I said I would appeal a sentence. Final sentencing was delayed. I have added other pertinent notes to the hearing-transcript (Doc. 11 P146, 147, 156, 157, 158, 162, 163, 167).

Statement of the facts (continued)

- 57.
13. 22/03/2016 - Gibraltar Magistrates' Court hearing: I presented my emergency Austrian passport.
14. +20/4/2016 - Gibraltar Magistrates' Court hearing: I presented my full Austrian passport (Doc. 20 P194). I was asked to "regularise" my residence in Gibraltar with its Civil Status and Registrations office.
15. 25/04/2016 - I lodged a 2nd written statement with the Gibraltar Magistrates' Court demanding that the charges be dropped in the light of my full Austrian passport and my obvious Britishness and a repeat of my former Law arguments, and that my name in CAPITALS in the charge refers to a covert government corporation, which contravenes Deuteronomy 4:2 12:8 12:32, and which I never gave my consent for (Doc. 12 P170).
16. 20/05/2016 - I lodged a 3rd written statement with the Gibraltar Magistrates' Court proving that the judges' oaths contravened the 1st Commandment to serve ONLY God (Mark 12:30), and I repeated my former arguments (Doc. 13 P172). And I lodged a 4th written statement with proofs that The Laws of God are prophesied to return to the world via Gibraltar, and nothing can stop it (Doc. 14 P174).
17. 31/05/2016 - I lodged a 5th written statement with the Gibraltar Magistrates' Court about Mrs. Elizabeth Battenberg's phenomenal fraudulent wealth, which British monarchs are specifically forbidden (Doc. 15 P176).
18. 28/06/2016 - NB. NB. Crown Prince and Archangel Michael the Christ/ Messiah: the rightful King of Gibraltar, lodged His 27/06/2016 Affidavit of Truth with the Gibraltar Magistrates' Court attesting that He owns this world and everything in it, and that I have His permission to be in Gibraltar (Doc. 16 P178). He also lodged an Amicus Curiae brief/Friend-of-The-Court statement with His warnings to be taken seriously and a scriptural explanation of the Brexit result (Doc. 17 P186).
19. 14/07/2016 - In my response (Doc. 18 P187) to Gibraltar Civil Status and Registrations' automatic-passport refusal (refer to point 10), I proved that Mrs. Elizabeth Battenberg, through her South African BAR (British Accreditation Registry) advocates and judges covertly "governs" South Africa and its parliament, via proscription of the parliamentary legislation, and judicial enforcement through its legal system, and that therefore the Coronation Oath's "govern the Peoples of the Union of South Africa" is correct, and the letter referring to "independence" and legislation etc. is incorrect.
20. 16/07/2016 - Gibraltar Civil Status and Registrations refused to accept and process my British Citizenship application.
21. 18/07/2016 - NB.NB. Crown Prince and Archangel Michael the Christ/ Messiah: the rightful King of Gibraltar, lodged a warning, which was given to all Gibraltar authorities mentioned above and to the Governor, to stop harassing me and to give me the British passport (Doc 19 P189).
22. 28/07/2016 - Gibraltar Civil Status and Registrations also refused to accept my residence application so I sent it to them by registered mail (Doc. 20 P190). I don't have a bank account, job-income, medical aid, etc. I have a spiritual calling (see point 50).
23. 02/08/16 - I lodged my British Citizenship request with the Gibraltar Governor (Doc. 21 P204).
24. 23/08/2016 - Gibraltar Magistrates' Court final hearing (Doc. 22 P206): They could not wait for a "successful" Gibraltar residence or British passport award. I said no document in the British Empire superceded the Coronation Oath (Doc. 22 P211). I explained the Deuteronomy 28 blessings for keeping God's Laws and the curses (Doc. 22 P218) for going against Them (Doc 23 P230), and that the fraudulent house of Battenberg/ Windsor was doomed and they should choose. They sentenced me to deportation and a fine of £200 (Doc. 24 P238 & Doc. 48 P392) and said I could appeal.
25. 24/08/2016 - I lodged my notice of appeal to the Gibraltar Supreme Court to continue challenging their jurisdiction (Doc. 25 P239).
26. 09/09/2016 - The Gibraltar Magistrates' Court dropped the deportation order (Doc. 24 P238).
27. 12/09/2016 - I lodged a first written statement in the Gibraltar Supreme Court stating that the conviction against me declared the Coronation Oath a fraud and a sham, which it is not: it REPEATS the promise by the British Israel nation with Moses before God at Mount Sinai to keep His Laws, which are the RULES for this PRISON planet with DEATH clauses for hating Them; also repeating my former arguments, and proofs that Mrs. Elizabeth Battenberg is the world's greatest criminal for, as the retainer/ watchman (Ezekiel 33:6) of Christ's British sovereignty: The King of kings, the world's blood is on her (Doc. 26 P240).
28. 14/09/2016 - I gave a copy of that first Gibraltar Supreme Court lodgement to the Gibraltar Governor (Doc. 27 P247).
29. 22/09/2016 - I discovered that Gibraltar is "legally?" selling British passports to high-net-worth non-British persons, while I, who am British, am criminalized (Doc. 24 P238) as a supposedly non British person, which I reported to the UK Passport Office (Doc. 28).
30. 29/09/2016 - The UK Passport Office gave a noncommittal reply (Doc. 29 P252).
31. 13/10/2016 - I lodged a 2nd written statement in the Gibraltar Supreme Court. Being a bit amazed that the obvious truths and seriousness were still not comprehended I challenged them to the Koran curse-duel - from the Sura (3) about Moses' family (see King of kings' Bible JAHTruth.net/kofk-free/Bible) - which WILL expose the lying parties (Doc. 30 P253).
32. 17/10/2016 - I lodged a 3rd written statement with the Gibraltar Supreme Court: the factual PROOFS and signs of Christ's presence on Earth now, and that He is waiting for our free-will acknowledgment of Him, before He comes "on clouds" when it will be TOO late (Doc. 31 P255).

Statement of the facts (continued)

- 58.
33. 25/10/2016 – The Gibraltar Governor formally refused to override the Gibraltar government and give me the British Citizenship (Doc. 32 P263).
34. 04/01/2017 – I lodged a 4th written statement with the Gibraltar Supreme Court: Romans 13:1-5 and Titus 3:1 refer to governments which follow God's Law, not legislation which is fraud, and repeated my former arguments (Doc. 33 P264).
35. 11/01/2017 – Gibraltar Prosecution issued their pre-hearing skeleton arguments – not addressing my factual arguments, because they cannot defeat them (Doc. 34 P266).
36. 12/01/2017 – NB. NB. I lodged the VERY important response to Gibraltar Prosecution's pre-hearing skeleton arguments with the Gibraltar Supreme Court (Doc. 35 P269), further proving the authority of my Law arguments, also proving that the British monarchy KNEW that their dynasty had ended with the true Coronation Stone's – Patriarch Jacob's pillow stone (Genesis 28): Christ's Throne - removal from Westminster Abbey on CHRISTmas morning 1950; restated my former arguments, and conveyed the promised blessings that would flow from accepting Christ and the truths presented.
37. 13/01/2017 – Gibraltar Supreme Court hearing (Doc. 36 P294): The Chief Justice rejected that he should recuse himself, and proceeded with his mostly one-sided hearing, and did not address the VERY important facts in my 12/01/2017 submission, calling them a "belief system", when they are irrefutable FACTS, not beliefs, after he denied me Mrs. Elizabeth Battenberg with requested exhibits so I could prove their correctness, and relied instead on the fraudulent legislation to uphold the magistrate's decision (Doc. 37 P325). And more pertinent points at Doc. 37 P309, 311, 312, 314, 318.
38. 25/01/2017 – I lodged notice of appeal (Doc. 38 P326) to the Gibraltar Appeal Court to continue challenging their jurisdiction, in which I repeated my former arguments, also citing errors in the hearing transcripts; some prejudicial to me.
39. 25/01/2017 – I applied for and got exemption from the Appeal Court fee, proving my lack of conventional job-income: doing "spiritual" work etc. (Doc. 39 P334).
40. 27/02/2017 - I lodged the grounds of appeal with the Gibraltar Appeal Court (Doc. 40 P336) confirming my former arguments and facts.
41. 09/03/2017 – I notified the Gibraltar Registrar of errors in the Record of Proceedings and of the missing 02/02/2016 hearing-transcript for the Appeal Court hearing (Doc. 41 P357).
42. 24/03/2017 – Gibraltar Prosecution delivered their skeleton arguments, again ignoring my facts (Doc. 42 P358).
43. 27/03/2017 – I lodged my response to the Gibraltar Prosecution skeleton arguments (Doc. 43 P362) correcting its errors and the hearing transcripts' errors, and restated that the legislation was not Law but fraud, as was Mrs. Battenberg.
44. 30/03/2017 – The Gibraltar Appeal Court hearing confirmed that they had read my lodgement and all prior submissions and hearing-transcripts. I reminded them of the British Israel people's promise with Moses at Mount Sinai before God to keep His Laws in "PERPETUITY" (Deuteronomy 29:15), which therefore applied to the persons in that very room. I asked them to give an order that the British passport be given to me, because they would be listened to (My request for this hearing transcript was ignored). In the final "judgement" (Doc. 44 P367) they UNDERMINED the Coronation Oath, because it contains the true EVIDENCE upon which my Law arguments hang, and labeled my facts and arguments in derogatory terms (using deceitful legalese?) and upheld the former decisions.
45. 04/04/2017 – I formally complained to the Gibraltar Courts' Registrar (Doc. 45 P370) that the three presiding persons at the Appeal Court hearing were current and former Privy Counsellors, whose obvious very-privy oaths of allegiance to fraudulent Mrs. Elizabeth Battenberg rendered them COMPLETELY unfit to give me an independent and unbiased hearing.
46. 04/04/2017 – The Gibraltar Courts' Registrar's reply was unhelpful (Doc. 46 P372).
47. 18/04/2017 – I lodged a list of the hearing-transcript errors with the Gibraltar Courts' Registrar that I managed to find (Doc. 47 P374), some of which prejudice me.
48. 20/04/2017 – I submitted my notice of appeal etc. to the UK Judicial Committee of the Privy Council (Doc. 48 P376) to continue challenging their jurisdiction.
49. 09/05/2017 - I requested all hearing recordings from the Gibraltar Courts' Registrar to make corrections (Doc. 49 P395).
50. 25/5/2017 – I wrote to the Gibraltar Chief Justice (Doc. 50 P396) that in my "spiritual work" capacity I exceed the requirements of the 'President of the Methodist Conference vs Preston UKSC 29' case: "God is above the law", which had just come to my attention: I fall under God's Law jurisdiction, not the legislation, so he could quash the fine.
51. 31/05/2017 – The Gibraltar Chief Justice replied that he was "functus officio"/mandate-expired (Doc 51 P398).



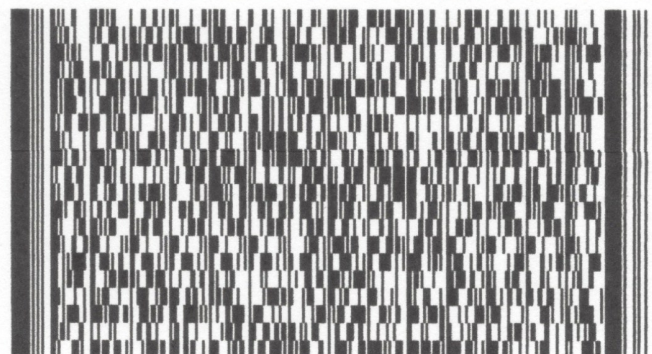
